## **About Us**

Moredun is committed to promoting livestock health and welfare through research and education and is recognised worldwide for its contribution to find solutions to combat infectious diseases of livestock.

Formed by farmers for farmers in 1920, Moredun has strong connections with the livestock agricultural community and is very active in Knowledge Exchange to ensure that the research arising from the Moredun Research Institute is useful to the livestock industry.

Today, employees of The Moredun Group provide a wide range of services including reception, HR, finance, engineering, stores, and general maintenance in addition to science research. All employees are based on the Pentlands Science Park and Firth Mains Farm. Moredun continues to work closely with the farming community, providing support through the development of vaccines, diagnostic tests and management strategies to help reduce the burden of disease.

The Moredun Group comprises The Moredun Foundation, the Moredun Research Institute, Moredun Scientific Limited, Pentlands Science Park Ltd., the Equine Grass Sickness Fund (a division of the Foundation), Wormvax Australia Pty Ltd and several smaller/dormant companies.

### **Our Objectives**

The Moredun Foundation is a registered charity that supports animal health and welfare through research and education and is the governing body of the Moredun Group.

The Moredun Foundation is dedicated to improving the understanding, treatment and prevention of infectious diseases by developing a variety of outreach programmes for farmers, vets and the general public; and supporting a broad and varied range of research initiatives within the Moredun Research Institute.

Moredun has always maintained a close working relationship with the farming community. We continue to be very active in this area of knowledge exchange to ensure that our research remains rooted in the practical needs of livestock farming today.

It is also the owner and landlord of Pentlands Science Park which extends to 22 acres and provides purpose built offices, laboratories and animal accommodation which is home to around 20 tenant companies working in a wide range of commercial and research fields.

#### The Moredun Research Institute

To lead in livestock health solutions for environmentally sustainable global food security

Moredun Research Institute is world renowned for research into animal health and welfare and providing solutions to prevent and control disease.

Moredun's research has led to the development of many vaccines, diagnostic tests and improved treatment strategies for farm animals across the globe. Moredun has extensive Home Office Licensed laboratory and animal facilities which underpin our research.

Our laboratories are equipped to handle a broad range of livestock pathogens including bacteria, viruses and parasites. Our on-site animal accommodation houses all species of livestock. The animal facility is an integrated complex incorporating purpose-built farm animal accommodation and a post-mortem suite.

An extensive high containment facility provides optimal controlled environmental conditions for large and small animal species and facilitates research on specified pathogens up to Containment Level 3. We also have 150 Hectares of grazing land in paddocks which are used in our research projects. Our facilities are staffed by highly trained and dedicated individuals including experienced veterinarians, who provide expert animal care and maintenance.

The Moredun Research Institution is a member of SEFARI (Scottish Environment, Food and Agriculture Research Institutions), a consortium of six globally renowned research institutions. SEFARI aims to deliver 'Leading Ideas for Better Lives' reflecting that publicly funded research in Scotland must ultimately deliver positive impact for individuals, whether in Scotland or



elsewhere. As a collective, it collaborates to deliver the Scottish Government funded Strategic Research Portfolio 2022-2027 on agriculture, environment, food, land and rural communities.

#### **Moredun Scientific**

To be a leading global provider of research and testing services to the animal health, aquaculture and biotechnology industries

Moredun Scientific is a contract research organisation specialising in animal health and aquaculture product development and biosafety testing of biopharmaceuticals.

Established in 1988, Moredun Scientific is the commercial arm of the Moredun Foundation. The profits are transferred to the Foundation, which uses the funds to support further research programmes at the Moredun Research Institute.

Our Animal Health services give clients access to our broad range of infectious disease models, expertise and extensive facilities to progress the development of their livestock vaccine and therapeutic products

We have completed over 500 studies and work with global animal health companies, biotech companies and academic organisations. Our Aquaculture business delivers contract research services to support the development of fish health products for the aquaculture sector. We work with pharmaceutical companies, feed companies and other organisations to conduct efficacy and safety studies in aquaculture species

We deliver regulatory compliant testing of biopharmaceuticals and cell lines to ensure they are free from contamination with adventitious agents. Our team of experts are committed to the on-time delivery of test results to meet regulatory requirements.

### **Main Purpose of the Job**

To manage the Finance and Purchasing/Stores Departments and be responsible for all financial activities for The Moredun Group, including for the Foundation, Moredun Research Institute, Moredun Scientific Limited, Pentlands Science Park Limited, Wormvax Australia Pty Ltd and other non-trading group companies.

### **Key Reponsibilities**

- Prepare consolidated and individual company annual statutory accounts and monthly management accounts to applicable legislative and financial reporting standards for the companies and charities of the Group.
- Provide annual budgets for the companies and charities of the Group.
- Meet internal and external audit requirements, including procurement and appointment of auditors – both internal and external – in conjunction with the Group Audit Committee.
- Servicing the Group Audit Committee.
- Contribute to strategic and business planning through contributions to all Board meetings for the companies and charities of the Group, and with the Senior Management Group.
- Work with the Director of MRI/Group CEO and the MD of Moredun Scientific, and the other members of the Senior Management Group to generate new business opportunities for the Group.
- Work with the Director of MRI/Group CEO, the Chief Operating Officer and the Science Park Manager to manage the estate and related property functions.
- Direct and manage the Finance Team, the Purchasing & Stores Team and the administration of the various funds within the Foundation.
- Participate in knowledge exchange/training of staff relating to financial matters.
- Manage the treasury and investment portfolios to maximise returns and balance and balance risk profiles.
- Hold the office of, and undertake the duties of, Company Secretary within all the group companies to ensure compliance with company law obligations.

- Manage financial and procurement systems to generate efficiencies within the group where possible.


